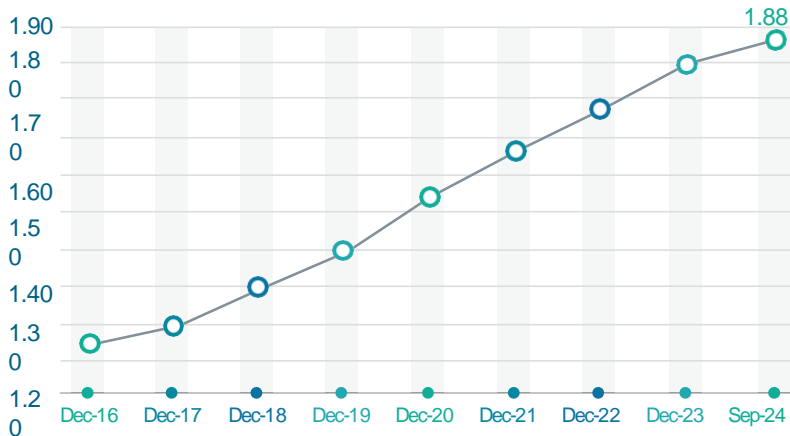
COMPANY PROFILE:
